February, 2006 M Holdings Co., Ltd with the capital Yen 100 million was newly established by separating from

Matsuzawa Co., Ltd.

- March, 2007 GARBO Co., Ltd. was established to start providing new services including the franchise head quarter for Mame-kichi Honpo and management of restaurants in Tokyo
- January, 2008 ISO 9001 certificate was granted to production departments and wholesales departments at all branches
- February, 2008 The capital for M Holdings Co., Ltd. was decreased to Yen 100 million
